We are excited to tell our members that we are currently researching the possibility of offering a "Broadband Only" (internet) service.

Due to potential new regulatory options at the federal level, a "Broadband Only" service may be considered as a possibility for our members. In efforts to research the feasibility, we need our member's assistance. A "Broadband Only" survey has been mailed out to all of our internet customers. We ask that you complete the survey and return it to our office by May 10, 2017.

Please understand that we are in the preliminary stages of gathering the critical information. The decision to move forward will not be made until we have had careful review of the data available. The option for a "Broadband Only" service must be determined to be beneficial and at the request of the majority of our members. A majority vote for "Broadband Only" would simply allow us to be able to offer that as an optional service and it would not eliminate our current services. 2586

FTTH Construction Update

Monitor Telecom now has approximately 350 customers cut to fiber. This year's budget includes 80 new drops, and changing out some antiquated equipment from the first phase of the build. The underground Fiber construction is nearing completion. If you are one of the 80 that has had a drop put in this year and have not heard from an electrician yet, you will shortly. Once the electrical has been completed, Monitor Telecom Techs will install equipment at the side of the house, and schedule for the final install. Power Outages

Our community certainly got hit hard with the recent wind storm and we understand all the concerns that go along with having no power. There were many of you in the community who didn't have it for days. Although our crews were monitoring the outage, there really wasn't much we could do until power was restored.

Some things you should know about your phone and internet if they are now on fiber to the home is that they require power. This means that the internet will not work without power and your telephone is estimated to work up to eight (8) hours with the current backup battery we provide. If you are interested in additional battery backup, please contact our office for information. Our staff monitors outages and we encourage you to contact us anytime you have a concern. Mother Nature can certainly make us appreciate the daily luxuries we have come to expect. We appreciate your patience and the opportunity to continue serving you.

Secure Passwords

What makes a good password? Ideally, each of your passwords should be at least 16 characters long. The longer the better! Passwords should contain a combination of numbers, symbols, uppercase letters, lowercase letters, and spaces. The Password should be free of repetition, dictionary words, usernames, pronouns, ID's and any other predefined number or letter sequences.

It can be very overwhelming trying to create and keep passwords. 2164 Try using a password manager program, the best part of a password manager is that you only have to remember the one password to access the program or the secure site that stores your password.

Calling to have underground utilities located before you dig isn't just a recommendation it's the law. Monitor Telephone reminds you to also contact Diggers Hotline for simple projects like planting a tree or shrubs, installing a deck, or putting up a new fence. You may avoid the service interruptions or physical injury that could happen if you hit electrical, gas, cable, television, or other service lines. There could be fines and repair costs. Just call the national hotline number (811) a few days prior to your project. Thank you in advance for your cooperation.

How Does It Work?



Understanding Wi-Fi

Wi-Fi is simply an alternative to network cables, as a way to connect devices of a local area network.

Wi-Fi allows devices to connect to one another the same way as when network cables are used – just without the actual cables. It uses radio frequencies (2.4GHZ and 5GHz) similar to cordless phones. Much like those phones, Wi-Fi has a limited range. This means the further you are from the Wi-Fi router, the slower the speed will be.

The number of devices you have connected to a Wi-Fi router also makes a difference. Wi-Fi has limited radio frequency spectrum ("bandwidth"). Because of this, too many devices trying to use it at once can cause a traffic jam, leading to slower speed. Wi-Fi is just one way to bring internet to a device.
