Fifty eight cooperative members, their family, Board of Directors, General Manager and staff attended the company meeting. Board Chair, Barbara Iverson, welcomed all in attendance, and a motion to approve the 2017 Annual Meeting Minutes was passed. Members then had the opportunity to introduce themselves and where they went to school. Their participation was well received, and a good start to the meeting. Geri Fraijo presented the General Manager's report that reviewed the 2017 year, which included fiber update, collaboration with ColtonTel, and announced the Broadband Only option that will be available in May 2018.

Next, Kira Tipikin, winner of the 2017 FRS Youth Tour, presented a slideshow of her Washington D.C. trip and shared what she learned, and her heartfelt appreciation of the war memorials. Patronage Disbursement

The Board of Directors has approved a patronage disbursement for years 1998 (100%) and 2016 (25K)

Patronage disbursements are the cooperatives way of returning the profit generated from the operation of business to its member-owners based on their purchases of local telephone and internet services. It is the cornerstone of Monitor Telecom's cooperative business model and is one of the things that sets co-ops apart from corporations.

This years' disbursement for 1998 (100%) and 2016 (25K) totaled over \$88,800.00 back to the cooperative members! That figure is impressive. Not only does it display the Cooperative financial health, but the support of each member.

A disbursement form was mailed to all members, earlier this year, to notify them and confirm mailing addresses. Many have returned the form and have already received their check. But there are still quite a few who haven't responded. If you were an active member during that time and did not receive a check, please contact the business office (503) 634-2266.
